The majority of parents are happy with what is being provided. The preschool is offering a “version” of online preschool and 2/3 of the students are enrolled at a reduced tuition. There is tuition “grace” being extended to families who have lost jobs.</p> <p>Online worship is going well. More people (school families, members who didn’t attend as much in traditional worship, others) are being reached. Possibility of continuing an “alternate” service as we come out of SIP.</p> <p>Confirmation is on Zoom, other youth ministries are starting on Zoom. Children’s messages are part of the service.</p> <p>Principal call committee conducted second interviews which included meeting with the staff and leadership team. The hope is to bring one of the candidates forward to the board as soon as possible. Board will meet at 8pm tomorrow (Friday, April 17).</p> <p>The PPP has gone through Umpqua Bank and has been forwarded to the SBA.</p> <p>We are still in good financial shape, although April offerings are down as compared to last year. School income will be down because of the reduced preschool tuition as well as families not being able to pay due to job loss presently.</p> <p>Tim and Pastor Mike are working on the ministry plan and budget for next year. We need to check on how we can do a voter’s meeting depending on how long SIP lasts.</p>
