The school budget is not finished as of this meeting as there was a slight change regarding salaries due to more hours being worked to meet state regulations for preschool. Next year Coach Johnny will be working part time in the preschool as well as teaching PE. There is a possibility of "\$70000 deficit in order to meet the needs for staffing next year. Once the budget is finalized the board may need to meet again before May to look at it. Misión de Jesus- There will be a meeting on May 3rd with Pastor Mike, Link, Greg Finke, and possibly others to discuss next steps/future of Misión de Jesus when Francisco retires next year. We are still waiting for a date for the fence installation around the field due to changes the city wanted made for permitting. Hearing Loop is installed and working well. Pastor Mike would like to put a Ministry Advisory Team together to meet quarterly as he prepares to retire in the next few year so there is a smooth transition as well as providing counsel to Pastor on various situations within the church There will be a meeting this Sunday (April 23) right after church to talk about the church financials.
